

CLASSIC BOATS 2011

further information regarding participation

The 15th specialized boat show will take place in Enkhuizen on November 4th, 5th and 6th, 2011.
Set-up stands: November 3th, 2011.
Breakdown stands: November 6th, after 18:00 hrs. and November 7th, before noon.

Official opening hours:
Daily from 10:00 – 18:00 hrs.

COSTS

Stand in heated exhibition tent 'Beursplein':

- Regular stand construction: booth, system-build: walls, frieze, company name: € 125,00/m². Smallest available size is 4 m².

Attention: mentioned price does not include illumination and floor covering.

- Market stall (top 3 meters long x 1,20 meters wide): € 545,00
- Space only (own stand): € 85,00 /m.
Smallest available size is 4 m².

Berth and/or space on shore for:

a ship smaller than or equal to 10 meter:	€ 420,00
a ship longer than 10 meter per meter length extra	€ 20,00
In combination with an indoor stand or (largest ship) outside every following ship:	
a ship smaller than or equal to 10 meter:	€ 210,00
a ship longer than 10 meter per meter length extra	€ 10,00

Length is total taken up size, rounded off by meters.

The organization has the right to more ships of one participant if necessary double.

Environment and publication contribution:

Each exhibitor has to pay € 85,00.

All mentioned rates are excluded 19% VAT and possible crane fees.

ELECTRICITY

Two 220V sockets per stand (max. use 1,5 Kw) are included in the price; if more than 1,5 Kw is needed, € 50,00 per extra 1,5 kW will be charged; 380V possible on request.

STAND-DISTRIBUTION

If the entry form is returned before August 15th, 2011, participants of former editions will have preference over new entries. The organizers reserve the right to decide on the eventual participation.

SUBLETTING

Subletting is not allowed

COMBINED STANDS

Combined stands are only allowed if this is evident in the stand name. Per extra exhibitor € 210,00 + € 85,00.

FURNITURE

Furniture can be ordered directly from the stand building company.

ENTRY TICKETS FOR PROMOTIONAL PURPOSES

You can order promotional entry tickets from the organizers. After the show only those tickets which are actually handed in at the gates will be invoiced.

For these tickets participants will be charged € 7,50 (€ 10,00 -/- € 2,50 discount) per ticket.

CANCELLATION COSTS

Before September 15 th , 2011:	no cost
From September 15 th until October 15 th , 2011:	50% of participation cost
After October 15 th , 2011:	100% of participation cost.

TERMS AND CONDITIONS OF PARTICIPATION

In this regulation the following words stand for:

- The Organiser: Klassieke Schepen v.o.f. registered in Alkmaar.
- Agreement of Participation: The agreement whereby the organizer, for a limited period of time and under specific conditions, agrees to offer stand space or services to an exhibitor.
- Exhibitor: The person who has signed the agreement as representative of the company exhibiting.
- The Exhibition: The exhibition for which the agreement of participation has been signed De
- The Stand: The space, measured in square meters, which has been offered to the exhibitor and of which the location and shape will be defined by the organizer.
- Stand fees: The amount which, according to the agreement of participation, is owed by the exhibitor to the organizer for goods and services rendered or to be rendered by the organizer and described in the agreement of participation.
- Berth and/or space on shore: The exhibition space for a ship in the water and/or on shore (on trailer or cradle) will be indicated by the organization

TERMS:

1. ENTRY FOR STAND SPACE, BERTH and/or SPACE ON SHORE

- 1.1 By signing this entry form the Exhibitor declares to have taken notice of and to abide by the terms and conditions of participation as defined in this form.
- 1.2 The Organizers reserve the right to refuse certain companies if the goods or services offered do not, to the opinion, fit into the objectives and principles of the show.
- 1.3 Sub-letting of stand space is not allowed. Combined stands as with the British Pavilion are only allowed if this is evident in all announcements and publications.

2. DATE AND DURATION

- 2.1 If exceptional circumstances warrant such a decision by the Organizers, the Organizers reserve the right to change the date of the Exhibition or to cancel it altogether. In the latter case amounts already paid to the Organizers will be fully refunded and all outstanding amounts and invoices will be cancelled.
- 2.2 Under exceptional circumstances can among others be understood: insufficient response, insufficient representative companies, internal differences within the trade branch and all other circumstances that after careful consideration by the Organizers of all interests involved could endanger the success of the undertaking.
- 2.3 If the date of the event is changed the Agreement of Participation will still be in force. In all cases the Exhibitor is held to pay the expenses incurred for his sake, at his request or in any way associated with his participation.

3. PAYMENT

- 3.1 The stand costs are due for payment on the dates as written down in this Agreement. All other invoiced costs are due within 30 days of the invoice date unless another date has been agreed upon.
- 3.2 The Organizer reserves the right to send out an invoice as soon as the Agreement of Participation has been returned.
- 3.3 The Exhibitor is responsible for all costs owed to the Organizers that in any way are associated with his own participation or a third party acting in his name.
- 3.4 The Organizer has the right to levy interest over amounts due as agreed in the Agreement of Participation but not paid on time. The collecting fee shall be invoiced to the Exhibitor whereby the extra judicial expenses shall be fixed at 15 % of the total invoice.
- 3.5 The Organizer has the right, after written or oral confirmation of proof of default, to terminate the Agreement of Participation immediately if the Exhibitor has not or not fully paid the amounts due at the agreed time. In that case the Exhibitor is still held to fulfill the financial obligations for the stand costs or other costs incurred on behalf of the Exhibitor without any rights for compensation in any way for damages way for damages way for damages the termination of the Agreement of Participation.

4. LIABILITY

- 4.1 The Organizer shall not be liable for any loss, damage, injury, delay, costs or expenses suffered or incurred by the Exhibitor, his sub-contractors, his or their visitors, servants or any other person due to cause beyond the control of the Organizer including acts of government, strikes, lockouts, fire, lightning, aircraft, explosion, flooding, riots, civil commotion, acts of war, malicious mischief or theft.
- 4.2 The Exhibitor indemnifies the Organizer against every conceivable claim from third parties for damages, in whichever way, caused by the Exhibitor, his staff or his visitors. The Exhibitor must insure himself against these possibilities.

5. CANCELLATION

- 5.1 The Exhibitor can not single-handedly change his entry.
- 5.2 There will be no charges for cancellations before September 15th, 2011.
- 5.3 For cancellation from September 15th until October 14th, 2011 the Exhibitor will be charged 50% of the total stand costs.
- 5.4 Exhibitors canceling as from October 15th, 2011 will forfeit 100% of the total stand costs.
